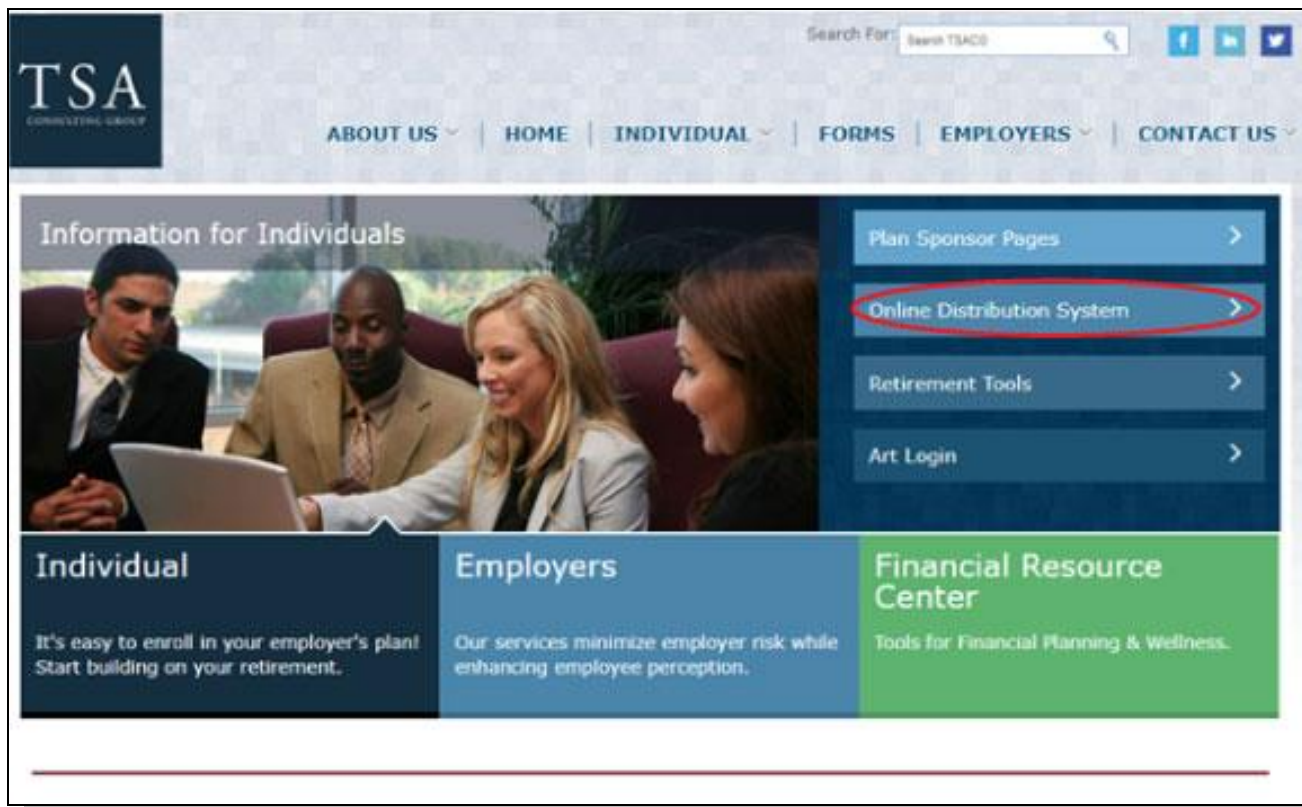




Online Distribution System Now Available
